- 2 Name of Post** : Drugs Inspector
- 3 Scale of pay** : ₹20740-36140
- 4 Number of vacancies** : 4 (Four)

The above vacancies are now in existence. - 5 Method of appointment** : Direct Recruitment  
Note: 3% vacancies of the post will be reserved for differently abled candidates with Locomotive Disability/Cerebral Palsy, Hearing impairment.
- 6 Age limit** : Age: 21-36 Only candidates born between 02.01.1980 and 01.01.1995 (both dates are included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities.

## 7 Qualifications

Degree in Pharmacy of a recognised University

Note: Rule 10(a)(ii) of Part II KS & SSR is applicable.

1. Persons appointed as Drugs Inspector shall be on training for Six months from the date of joining in service.
2. Probation with respect to the category of Drugs Inspector who are appointed by Direct Recruitment shall commence after successful completion of training.
3. Every person appointed as Drugs Inspector shall during the period of probation pass Account Test (Lower) or Account Test for Executive Officers if he has not already passed the same.

## 8. Mode of Submitting applications:

Candidates must register as per “ONE TIME REGISTRATION” with the Official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply now' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote User-Id for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, Experience, community, age etc have to be produced as and when called for.
