Degree in Mechanical Engineering/Mining Engineering/Agricultural Engineering with not less than 50% marks

Desirable : Two years experience in handling water well drilling rigs.

**Note :** 1. Probation : Every person appointed to this post shall, from the date on which he joins duty be on probation for a total period of two years on duty within a continuous period of 3 years.
